The parties anticipate that a number of these initiatives will occur during the period of this Memorandum of Understanding (MoU). However, neither party is obliged to agree any minimum number of activities, nor is this MoU intended to preclude either party from catering into similar agreements with other institutions.

This Memorandum of Understanding shall be identified as the parent document any programme agreement executed between the parties. Further, agreements concerning any programme shall provide details concerning the specific commitments made by each party and shall not become effective until they have been reduced to writing, executed by the duty authorized representatives of the parties.

For agreed upon activities, both institutions will make available their facilities and staff. This Memorandum of Understanding will take effect on and will be valid for Two (2) years from the date noted in the first line of this document unless terminated by one of the parties. Either party may withdraw from this agreement provided written notification of the withdrawal is given to the other party at-least three months prior to the desired with withdrawal date. This Memorandum of Understanding may be renewed for another period of two (2) years upon mutual written consent of the parties before the expiration date. Each institution will have copies of this agreement.
