GUEST LECTUER -05/10/2024

The Department of HISTORY &POLITICAL SCIENCE organized a guest lecture on the topic "Preamble of the Indian Constitution" on 05/10/2024. The lecture was delivered by the esteemed Dr. N.J. Padmakara Babu, Professor, Dept. of Pol. Science, Andhra University, who is well-known for his expertise in constitutional law and political science. The lecture aimed to provide students with an in-depth understanding of the philosophical and legal significance of the Preamble to the Indian Constitution. Dr. N.J. Padmakara Babu commenced the session by explaining the historical context in which the Preamble was drafted, emphasizing its role as a guiding light for the Indian Constitution. He elaborated on the key ideals enshrined in the Preamble—Justice, Liberty, Equality, and Fraternity—and explained how these principles reflect the vision of the founding fathers of the nation. The speaker explained the deep philosophical meaning behind each term in the Preamble, especially the words "Sovereign, Socialist, Secular, Democratic, Republic." He traced the evolution of these concepts in Indian polity and their importance in shaping modern India. Dr. Babu also shed light on the Preamble's legal standing, referring to landmark judgments such as the Kesavananda Bharati case (1973), where the Supreme Court recognized the Preamble as part of the basic structure of the Constitution. He stressed how the Preamble serves as a beacon in interpreting the Constitution and its amendments. The lecture concluded with a discussion on the relevance of the Preamble in today's socio-political context. Dr. Babu encouraged students to reflect on how the Preamble continues to guide India's democracy, particularly in ensuring social justice and upholding secularism and democratic values. All students and staff were presented in this session. Later the Principal incharge D.Ravi kumar, J.S.Suneetha Kumari Lect.in History and other staff, members felicitated the speaker.


The lecture covered:


Objectives of the Quiz

- Some students suggested including site visits or documentary screenings for better understanding.



- Faculty members and students actively participated in discussions.
- The historical images and documentary references added depth to the topic.
- Attendees suggested similar sessions on national symbols and historical movements for future faculty forums

Conclusion: The Faculty Forum session on the **Evolution of the Indian Flag** successfully enriched participants' knowledge of the historical and symbolic significance of the national flag. The session highlighted the role of the flag in India's freedom movement and its continued importance in national identity.
